- 1. Organizer of the International Meetings of Wind Orchestras "Alte Kameraden 2022" is the City's Culture Centre in Gorzów Wielkopolski/Poland.
- 2. Data of the International Meetings of Wind Orchestras "Alte Kameraden 2022": 21st May 2022
- 3. Goals:
  - a) In memory of the great Landsberg's composer Carl Teike, the so called King of Marching Music, and his works
  - b) Presentation of the performance abilities of different wind bands from marching music, folk music, Pop music, film music through out the transcription of classical music. Presentation of the traditions and specific ways of making music in the region the ensemble comes from.
  - c) Increase of cooperation between European ensembles
  - d) Promoting of the widely understood musical culture
  - e) Promoting of the culture of wind bands through extraction of laureates among the participating bands in two competition categories of the International Meetings of Wind Orchestras "Alte Kameraden 2022".
- 4. During the Meetings take part competitions in following categories:
  - Concert,
  - Orchestra's Tattoo Show
    - \*Every category will be rated separetely.
- 5. The International Meetings of Wind Orchestras "Alte Kameraden 2022" will take place online.
  - a. Wind Bands, Show Bands and Parading Bands, which present a artistic high level, can take part in the International Meetings of Wind Orchestras "Alte Kameraden 2022". This includes Polish bands and bands from abroad.
  - b. Participants of the Meetings are music bands, which consist primarily of wind instruments.
  - c. It is not allowed to take part in the competitions as a program band or project band/orchestra, which has no continuity of operation and was founded only for the reason of this participation. The qualification is based on the call.
  - d. It is forbidden to recruit additional musicians (this does not apply to conductors).
- 6. The rating of the artistic level of the participants of the International Meetings of Wind Orchestras "Alte Kameraden 2022" is based on the arrangements in the *One World Judging System* WAMSB and the resolutions in the Jury Regulations of the Meetings. In cooperation with the *Stowarzyszenie Polskie Orkiestry Dęte*, (Association of the Polish Wind Orchestras) the Meetings' Jury will consist of persons designated by the Juror Bureau of the mentioned association. This will be persons from Poland and abroad.
- 7. The qualification procedure of the International Meetings of Wind Orchestras "Alte Kameraden 2022":
  - a. Interested bands should send following documents to the organizer:
    - an internet link or an audio/video file with a presentation of the band on base of which the organizer will extract the Meetings' participants,

- a filled and signed entry form as a pdf-scan,
- a digital photo of the band in best possible quality and a description of the band.

- b. Deadline for calls: 11th March 2022.
- c. The qualification results will be published by the organizer on 15th March 2022.
- d. Qualified bands have to deliver competions' recording/s until 29.04.2022 in form as described in the Regulations to following address: info@mckgorzow.pl
- 8. Detailed regulations of the online-competition:
  - a. Last date to send the competitions' recordings is 29.04.2022.
  - b. The recording should be made as files MP4 or MOV with a minimum quality of 720p, horizontally (landscape).
  - c. The recordings should not be edited (audio, video). Furthermore the recordings should be made without any "live"-editing, by the use of only one camera.
  - d. The recording should be made in such way, that all musicians/ performers can be seen at all times.
  - e. The audio recordings should be realized by the help of only two microphones conneted with eachother.
  - f. The competitions' recordings should be made in the time frame from 15th March until 28th April 2022.
  - g. The concert's recordings and the recording of the orchestra's tattoo/ show should beginn with an oral introduction (as a part of the recording) with following content: "(BAND'S NAME), under the leading of (NAME AND SURNAME OF THE CONDUCTOR) presents itself during the International Meetings of Wind Orchestras "Alte Kameraden 2022".
  - h. An important part of the International Meetings of Wind Orchestras "Alte Kameraden 2022" will be the presentation of 2 music pieces by all participating bands: "Alte Kameraden" by Carl Tike and a Polish music piece chosen by each band itself. (The music sheets for the mandatory music piece "Alte Kameraden" will be send to the email-address the band mentioned in its entry form, after the band sucessfully passed the Meetings' qualification procedure.).
- 9. Detailed guidelines for the competition categories:

### a. <u>CONCERT</u>:

The band prepares a free concert program which sould be diversified and shows the band's abilities.

The program should contain two mandatory music pieces: "Alte Kameraden" – a march by Carl Teike - and a Polish music piece which can be chosen freely by the band itself.

The music band should present a concert lasting 20-25 minutes.

The jury can decide for negative points if the band crosses the time frame.

## b. ORCHESTRA'S TATTOO - SHOW:

Presentation time: 8 - 15 minutes.

Free repertoire.

#### 10. AWARDS:

- a. Every participant of the International Meetings of Wind Orchestras "Alte Kameraden 2022" receives a participating certificate and the recordings of its jury's ratings.
- b. The laureate of the competition category concert receives a financial award of 3 000 PLN brutto.
- c. The laureate of the competition category orchestra's tattoo/ show receives a financial award of 3000 PLN brutto.

#### 11. ORGANIZER:

- a. The organizer has the right to record and multiple publish and present the recordings of the artistic and image-building bands' presentations made during the Meetings on internet portals and other medias to promote the Meetings 2022 and to use them in future to promote the Internional Meetings of Wind Orchestras "Alte Kameraden", without paying the band a fee/ honorarium.
- b. The organizer has the right to choose the participants of the International Meetings of Wind Orchestras "Alte Kameraden 2022" on the base of the sent entry forms.
- 12. The participants of the competitions transfer their economic copyrights free of charge to the City's Culture Centre in following cases:
  - presentation of music pieces during the Competition,
  - presentation of music pieces during the Concert,
  - rights of their own image (made by all photographic and audio/video techniques) recorded during the participation in the Competition and the Concert.
- 13. The participants transfer above-mentioned rights, so that the City's Culture Centre can use them timed and territorial unlimited in following ranges:
  - consolidation,
  - reproduction in any technique,
  - implementation into the computer's memory, the internet or another element,
  - public playing and presentation,
  - o exposure,
  - displaying,
  - transmission via vision or sound, wired or wireless, through terrestrial and satellite stations.
- 14. The participants declare that their actions do not violate the rights of third parties, especially their financial or personal image-building copyrights. In case of claims of third parties based on violations of above-mentioned rights of third parties specific participant compensate the organizer, as exclusively reponsible, for the costs related to the indemnity claimes addressed to him. By doing so the organizer is free of any obligations, which arise in this case.

15. By signing the Regulations, the for the music band responsible person accepts all contained there arrangements and enters a contract with the organizer. All issues which are not covered by these Regulations shall be decided by the Meetings's committee. The committee informs the Meetings' participants about its decisions immediately.
